• Approving meeting minutes from last meeting at first regularly scheduled meeting.

5. ACTION ITEMS

- Bylaw Vote
- Purpose of Special Meeting: Review the recommendations made by the Rules Committee, discuss suggestions, and vote on changes
 - o Bylaw must be revised every 4 years.
 - o Bylaws were revised last year and submitted to Rules Committee of the Senate in the fall.
 - We heard back from them in May.
 - o Their role is to make CoE bylaws as clear as possible so there are not issues that arise later. After COEC has a final draft the Rules Committee will approve the draft and send it to the Senate for a vote.
- Kristina Falbe summarized the Rules Committee suggestions and made grammatical changes.
- Suggested changes to meaning were added to discussion list by Kristina Falbe
 - o Curriculum
 - Rules Committee Suggestion: There should be a full vote in every department or school before moving forward.
 - **Discussion:** After talking to past chairs and it is not recommended that we make this change to the Bylaws

- Question from Rochelle Borden- Are students represented on this committee? Discussion of whether students are on other committees. Curriculum is typically the purview of faculty. UCC has 2-3 student reps.
- Concern from Rochelle Borden- Faculty mainly look the same, a diverse perspective and diverse voices might be helpful.
 - Department bylaws discussion
 - Discussion of Diversity Education Committee
- **Result:** No vote taken since we are not making the change.

Vacancies

Rules Committee Suggestion: When is a seat considered vacant?
 Current language (person is unable to perform their duties) is vague and problematic. Suggestion is to define what constitutes a vacancy (ie. Misses 3 meetings)

Discussion:

- Are we working under the assumption of 3 missed meetings.
 - Erin Quast agreed.
- Change language to 3 or more missed meetings
 - Motion to Vote: Called to change language by Rochelle Borden
 - o 2nd- Kate Peeples
 - o In Favor-8
 - Opposed- 1 Gavin Weiser (3 is too many meetings to miss per semester)
 - Abstain- 1 Dean Godwyll
 - Friendly amendment-Erin Quast
 - Amend to 3 meetings per academic year to define a vacancy-
 - o 2nd Amanda Quesenberry
 - Move to vote- Gavin Weiser
 - Change the language to no more than 3 meetings missed per academic year to define vacancy
- **Result:** Kristina Falbe- Recommended holding the vote as the next conversation may impact our decisions.

Elections

- Rules Committee Suggestion: Holding election cycles may be problematic. Consider running elections as a seat vacancy occurs
- Discussion:
 - Kristina Falbe-
 - Robyn Seglem- History: In 2019 the Elections Committee requested a set election cycle due to low turnout. They felt the frequency of elections contributed to confusion over whether individuals had already voted, thus missing new elections. We

- have seen an increase in participation as a result of moving to election cycles.
- Current election cycles- August, January and April
- Sarah Ballard- Concern expressed over length between election cycles and conflicts that may arise like medical or teaching schedules.
- Kristina Falbe clarification- Speaking to seats vacated by missing 3
 meetings or not being filled. Not that someone is out on medical
 leave.
- Robyn Seglem clarification- Most vacancies happen at semester or in some cases the seat is unable to be filled.
- Rules committee is recommending we be clearer about when we are going to fill vacancies.
- Amanda Quesenberry question- Is this for all college level committees?
 - Kristina Falbe- Yes
 - Amanda Quesenberry- Do we need a different system for CC than all other committees?
 - Robyn Seglem- Bylaws state that the department can appoint if a seat becomes vacant say for missing 3 meetings.
 - o Rochelle Borden question- Why May and August elections?
 - Kristina Falbe- Because people may leave in the summer. An election in August would delay committees getting right to work.
 - o Gavin Weiser question- Do chairs know that they need to take attendance? Do we need to send out this policy?
 - Erin Quast- I don't think this should apply to subcommittees. They should have more flexibility. It would make it harder to get people to commit.
 - Gavin Weiser- You don't always know your schedules when you agree.
 - Kristina Falbe- We can separate. Rules committee asks for clarification about both types of vacancies. Subcommittees are required to meet once per month or per semester.
 - Amanda Quesenberry- This is about having a faculty voice in who represents each department on COEC.
 - Erin Quast- How quickly do elections move?
 - 2 Weeks are required 1 week to take nominations and 1 week to vote

- **Previously moved:** Change the number of missed meetings for College Council to 3 or more missed meetings per academic year to vacate a seat
 - Favor- 9
 - No- 0
 - Abstain- 1 Dean Godwyll
- Vote 2 (Election Cycles) Article 3 Section 4 College Council:
 - Move to Vote- Amanda Quesenberry
 - A special election will be held when a vacancy occurs in College Council.
 - Second- Rochelle Borden
 - Discussion:
 - Sarah Ballard question- What happens if regular election is happening soon?
 - Gavin Weiser- The Queer Coalition's constitution states how much of term is left.
 - Amanda Quesenberry question- If this changes then do we change the bylaw saying the Chair can appoint?
 - Kristina Falbe clarified: Section 5 Article 3- add "through a special election" 2 separate not necessary.
 - o Sarah- If an election cycle isn't within xx about of time
 - o Kate- 2-week election cycle
 - Rochelle- More than a month away
 - A special election should occur when a vacancy in CC is more than 3 weeks away.
 - Seglem- Maybe make the vacancy per semester
 - o Dr. Godswyll- lower to 2 meetings
 - A special election should occur when a seat is vacated in CC.
 - o Friendly amendment: Sarah
 - o If regular cycle is more than a month away.
- **Results:** Special election should occur when a seat is vacated in COEC if the regular election cycle is more than a month away.
 - Second- Rochelle Borden
 - Move to vote- Amanda Quesenberry
 - Favor- 8
 - Opposed-0
 - Abstain- 1 Dean Godwyll
- Committee Vacancies
 - **Rules Committee suggestion** Replace unable to perform duty with a specified number of absences.
 - Discussion:
 - Rochelle Borden question- How many committee meetings are held per semester?

- o CC gives the charge of 2-4 per semester
- Sarah Ballard question- Do we need to specify/set expectations across the committees?
- Dr. Godwyll question- Could we use the principle of ½ then you are considered a vacant seat.?
 - Sarah- Teaching schedule conflicts
- Kristina Falbe- Trouble filling committees due to schedules. CC may need to have a conversation about how to be transparent about meeting schedules.
- Dr. Godwyll- Consider practice of other universities by defining excusable absences and the number permitted.
- Rochelle Borden- Have each committee determine what is excusable.
- Gavin Weiser- Attendance is important, but sometimes people show up and don't do anything.
- Amanda Quesenberry- Could be similar to faculty meetings, complete form when missing meetings.
 - o Sarah Ballard- Are we policing faculty for their service?
 - o Kate Peeples- Is this more than my department asked of me?
- Kristina Falbe- Rules Committee suggestion- "Unable to perform duties"- Who decides this? Replace with more specific.
 - Gavin Weiser suggestion- "unable to perform duties as outlined by the committee description in the bylaws"
 - o Discussion on temporary replacements.
 - Gavin Weiser- There is a difference in schedule conflict and no call no show? It is about communication.
 - Not a clear distinction. There should be a difference when replacing "no call no show" and schedule conflicts
 - Amanda Quesenberry- Differences in the number of faculty within the 3 units in the college
 - o Gavin Weiser question- Where do the representatives come from when you have a smaller unit?
 - Sarah Ballard question- Does this go back to the chair of the committee? Does COEC have purview over this if faculty are not fulfilling responsibilities.
 - Dr. Godwyll- We are trying to protect vulnerable faculty.
- Kristina Falbe restated- The Rules Committee stated this so vague that this can be a place that people disagree.
- Kristina Falbe- Since we are struggling to define this, and we are close to our time limit lets pause committee vacancy discussion for online discussion

 Sarah Ballard suggested- Providing opportunities to give feedback within Teams as was done previously.

o Quorum-

- Rules Committee Suggestion:
 - Need to define a quorum, current language is too vague
- Discussion:
 - Define a quorum as the number of filled seats instead of total membership
- Sarah Ballard- Motion to change language- Define quorum as the total number of filled seats.
- 2nd- Rochelle Borden
- Move to vote
 - Approve- 8
 - Oppose-0
 - Abstain-1 Dean Godwyll
- Results: Passed- Define quorum as filled seats for subcommittees and CC.

o Chair

- Rules Committee suggestion: Who is eligible? Elect a chairperson from members that were elected to the committee unless committee bylaws state otherwise.
- Motion: Gavin Weiser
- 2nd- Sarah Ballard
- Discussion:
 - How do we want to define this?
 - Gavin Weiser- likes the language of elected members
- Move to Vote: Elect a chairperson from members that were elected to the committee unless committee bylaws state otherwise
 - Approve-8
 - Oppose-0
 - Abstain-1 Dean Godwyll
- **Results:** Passed- The chairperson will be elected from members elected to the committee unless the committee bylaws state otherwise.

Minutes

- Rules Committee suggestion: Minutes will be "posted" for each committee. Currently they are available by request.
- Move to vote: Rochelle Borden
- 2nd- Gavin Weiser
- Discussion:
 - Kristina Falbe- Friendly Amendment: Approved minutes will be posted to the COEC website.

- Currently only the Tech Committee submits to COEC. They can post directly and not move minutes through another layer.
- Vote to change language throughout document for all subcommittees to: Approved minutes will be submitted to the COEC website.
 - Approve-8
 - Oppose-0
 - Abstain-1 Dean Godwyll
- **Results:** Passed- Approved minutes for all subcommittees will be posted to the COEC website.
- Kristina Falbe- Talking points on topics needing more conversation will be discussed on the Teams site.

Addition of Staff to COEC

- o Kristina Falbe- At the end of working on bylaws last year, we were working to add staff members to the COEC.
 - Minutes state we want to do this.
 - There are decisions that need to be made around this.
 - Term length
 - Who is appointed?
 - Can they serve on the Executive Council?
 - Are they voting members?
 - Due to time, bringing this up as we are at the table discussing bylaws.
 - Kristina Falbe- Other colleges include AP and CS. Look at what was pulled by Stacy Jones Bach and see what we want to add.
 - Sarah Ballard question- Is it as easy as adding to our membership and applying all the same expectations?
 - o Kristina Falbe-That is on the table
 - Kristina Falbe-Consider how students are appointed. Not the same as other elected members.
 - o Kristina Falbe-We have AP and CS throughout the college.
- Kristina Falbe- Start thinking about this and share thoughts electronically so we can develop the language. Do we need a subcommittee for this?
 - Robyn Seglem- The commitment to participating in Teams dialogue helped move things forward last year.
 - Kristina Falbe- Changes will need to go out to all faculty. We may need a meeting between now and the next regular meeting.
 - Sarah Ballard- Can we wrap up Bylaws changes via online discussion?
 - The Executive council will meet to chat about a bylaws timeline so we can be efficient when we next meet.
