+ The Mississippi Research and Development Center is a non-degree-granting institution, with its program intimately related to those of the state universities.

In August 1968 the Board of Trustees of State Institutions of Higher Learning allocated a total of \$28,270,000 to ten institutions for fiscal year 1968-69 out of the "General support" appropriation of \$52 million for the biennium 1968-70.

To afford some impression of the identity of the institutions, Table 33 shows both the amounts allocated to the eight teaching institutions for fiscal year 1968-69 thus far, and one-half the amounts appropriated specifically by the legislature to the units and services associated with each institution. This allows subtotals for each of the state universities to emerge, which are presumably roughly comparable with those of similar institutions in other states.

- \* Pennsylvanians insist that this is not a state university, but "state-related" because its governing board has only a minority of its members appointed by public authorities. It is, however, for all intents and purposes the principal state university in Pennsylvania, as its name implies.
- \*\* Appropriated to enable the university to reduce student fees without loss of operating income. Note that much larger sums for this same purpose are appropriated to the two "state-related" private universities -- Temple and Pitt.
- \*\*\* Temple and Pitt are private corporations, with one-third of the members of their governing boards appointed by public authorities under statutes of 1965 and 1966. They are often grouped with Pennsylvania State University as "state-related," the three composing the "Commonwealth Segment" of higher education in Pennsylvania.

NOTE: An appropriation of \$1,581,692 to the Hahnemann Medical College failed to pass in the Senate prior to the break in the session in July 1968. It was thought that this appropriation might well be enacted after the legislature reconvened in September 1968; but the outcome could not be known when this report went to press in August.

It is difficult to compute the 2-year dollar gains and percentage gains

because the substantial sum of \$51,300,000 to the Higher Education Assistance Agency for fiscal year 1968-69 is reported, but no appropriations for student aids were included in reports of prior years. This undoubtedly causes the 2-year gain to be considerably exaggerated. With the \$51,300,000 included, fiscal year 1968-69 appears to be a gain of 92½ per cent over 1966-67; but with that item omitted, as in prior years, the gain over 1966-67 would be only about 55 per cent.

Similarly, the percentage of gain over eight years since fiscal year 1960-61 is either 509 per cent or 391 per cent. In this instance the higher figure is probably nearer the fact, because the tax support of student aids was certainly much smaller in 1960-61 than in 1968-69. In any event, for GRAPEVINE's purposes the larger figures must be used, both to make the 50-state total as nearly correct as possible for 1968-69, and to maintain Pennsylvania's proper place in comparison with other states.

All who have some comprehension of the diversities in the practices of the fifty states understand that it is never possible to achieve simultaneously both exact vertical (historical) comparability and precise horizontal comparability (among states and institutions); but that the approximations which are possible serve useful purposes.

Pennsylvania's total for fiscal year 1968-69 goes above those of Michigan (\$262,424,000) and Texas (\$259,425,000), placing the Commonwealth in fourth place among all the states, as befits its large population.

Following California, New York, and Illinois in their first, second, and third positions, Pennsylvania now pushes Michigan down to fifth and Texas down to sixth among the top states. This is further evidence that state support of higher education in the Northeast is in a strong upward trend.

The total for fiscal year 1968-69 appears to be a gain of 57½ per cent over the comparable figure for fiscal year 1966-67, two years earlier. The 8-year gain since fiscal year 1960-61 seems to be 259½ per cent.

These gains are well above the nationwide averages, and indicate prima facie that Texas merits praise for progress in tax support of higher education.

Texas is now among only six states that have appropriated more than a quarter of a billion dollars for annual operating expenses of higher education: California, New York, Illinois, Pennsylvania, Michigan, and Texas -- in that order. Texas is pushing Michigan very closely for fifth place. The margin between them is only about \$3 million.
