

Early Childhood Education-Online Workforce Program Frequently Asked Questions (FAQ)

	Question	Answer
Program Structure	What is the Early Childhood Education Online Workforce Program?	This online program is designed for professionals working with children birth through five years of age to obtain a bachelor's degree and Professional Educator License (PEL) in Early Childhood (birth-grade 2). Students' cost of attendance may be fully funded as part of the State of Illinois ' Early Childhood Access Consortium for Equity.
	How long is the program?	The program is designed to be completed in less than two years. Taking summer classes are required to complete the program in a timely fashion.
	Are classes asynchronous or synchronous?	Classes are synchronous, meaning classes run in real time, with students and instructors attending together via Zoom from separate locations. Students are placed in cohorts to have a more positive learning experience with classmates.
	When do classes meet?	Classes meet online, once a week in the evening. However, students must still participate in independent learning through our learning modules throughout the week. <i>The Fall 2023 Cohort will meet on Tuesdays from 5:30 p.m 7:00 p.m.</i>
	Will I be considered a full-time or part-time student?	Although classes take place once a week, the 8-week course model grants student full-time status. The fast-paced program allows students intensive learning experiences in a condensed manner to be able to obtain a bachelor's degree and join the early childhood education workforce.
	Will the program continue to be offered in the future?	Yes, we anticipate offering the Early Childhood Online Workforce program based on enrollment.

	How can I become a fully funded student?	Members of the early childhood education workforce may be eligible for the new Early Childhood Access Consortium for Equity (ECACE) Scholarship Program through the Illinois Student Assistance Commission (ISAC) that may cover all costs of attendance. Applicants must be an Illinois resident, a U.S. citizen or federal eligible noncitizen. 	How do I know if I have been approved for the ECACE scholarship?	Applicants will receive a pre-approval letter from ISAC confirming the ECACE Scholarship has been awarded.
	What transitional resources will be available to me?	Prior to the start of classes, students will work closely with the ECE Online Workforce Academic Advisor, to secure courses, financial aid, and materials to prepare for the semester.
		In addition to individualized support, students will be required to attend an online two-hour orientation prior to the start of the semester to meet professors, classmates, and ISU ECE Online Workforce Staff.
		Throughout the semester, students will have the opportunity to attend academic and topic related workshops.
